#### School Finances

Tax dollars are a very important resource for school districts in their efforts to educate children. Nebraska schools receive taxes and other receipts from local, county, state, and federal sources. As you look at the information included in this report, you will notice that the great majority of the dollars used to fund education in our district are generated by local tax dollars. The other resources are necessary yet they are small by comparison. The school fiscal year runs from September 1 to August 31 each year. School districts are required to have their budgets filed with the Auditor of Public Accounts and the Nebraska Department of Education prior to September 20. Preparing a budget is not always easy

because one of the largest factors in the school budget formula is the assessed valuation of property in the school district. School districts do not get certified valuation numbers from the County Assessor's Office until August 20. One month might seem like a long time, but unwanted surprises at this late time in the year can have a major impact on budgeting for the upcoming year. 



#### Seward Utilizes NWEA MAP tests at grades 2-11

Each year, students in the Seward Public Schools are administered an achievement test in the subjects of math, reading, science, and language usage. Students take these computerized tests in the fall and spring. These tests help guide instruction, but also help to show academic growth as the test is tailored to how well the student performs on the test. Many adults may remember, as students, taking some sort of test where they filled in little test bubbles on an answer sheet. That was likely a standardized achievement test.

#### What are standardized achievement tests?

Standardized tests are designed to make certain every student is "on the same playing field" when assessing their achievement - meaning that all students take the tests during the same time period, with the same directions, questions, and procedures. Test conditions are the same for all.


Standardized tests are developed so that schools can compare themselves and get a view of how their students are achieving compared with other students in the nation. Since it would not be possible to test and compare all the students in the nation at this time, a smaller sample of students is selected to base comparisons on. This group is called a norm group.


Scores on norm-referenced tests are often reported as percentiles. This is not the percentage of correct responses on the test. Instead, all the scores are ranked from first to last. The percentile score tells how the student scores rank as compared to that smaller norm group, based upon a standardized test. It tells only how children compare, not what they know or what they can do.

Criterion Referenced Test assess students on a specific set of standards and is reported out as proficient levels as below, barely, proficient, and advanced. These tests include the State Reading, Writing, Math, and Science. The test and the number of tests taken depend upon the grade level. The state tests is what you will see reported in the newspaper each fall.




### Spring 2012 NWEA Assessment Percentage (National average is 50 percent)






This is the fourth year for the state reading test, third year for the state math test, and the second year for the state science test in grades 5th, 8th, and 11th. This is the first year for 4th grade state writing test utilizing the new rubric and the second year for the state writing test at grades 8 and 11 with the new rubric. Seward Public Schools continue to score above the state average in almost all subjects and grades.

#### **NeSA Reading and Writing**




**NeSA-Writing Percent Proficient** 




### **NeSA Math and Science Scores**


**NeSA Math-Percent Proficient**

The Federal No Child Left Behind Act, requires that every child by the year 2013-2014 school year test proficient according to the NeSA tests in reading, math, and science. Schools must also report results by six subgroups: race/ethnicity, gender, ELL, students receiving special education services, students in poverty, and student in migrant programs. AYP (adequate yearly progress) is also determined at each individual school to see if all students within the school have made AYP along with the subgroups within each school. The district as a whole is also deemed making or not making AYP. The Nebraska State of the Schools report includes the list of districts and individual schools that did not make AYP for two or more consecutive years and has been identified as being in need of improvement.
